

TEXAS REAL ESTATE INSPECTOR APPROVED COURSES

The commission accepts courses as core inspection courses only if a final examination is successfully completed at the end of the course. Renewal courses do not require a final examination. "Core inspection courses" are educational courses approved by the commission, including but not limited to structural, electrical, mechanical, plumbing, roofing, business, legal, standards of practice, report writing, appliances or ethics, all of which must relate to a real estate inspection. See Subchapter A, Section 1102.001(5) of the Texas Occupation Code.

Effective September 1 2007, applicants for the Real Estate Inspector and Professional Inspector license who apply under the fast track alternative method must provide proof of both education and experience. Please see footnotes to determine which courses include experience.
